### THIS APPLICATION SHOULD BE ACCOMPANIED BY:

- ✓ Application fee of \$60. (\$120 fee if you are an international student or a student transferring from a college and/or university outside of Newfoundland and Labrador).
- ✓ Other documents as specified by the program for which you are applying. *All transcripts must be OFFICIAL and must be sent by the University or College you have attended, or the Department of Education, directly to the Marine Institute Registrar's Office. Grade Reports will not be accepted. If you attended Memorial University this information will be obtained internally.*
- ✓ An official transcript of your high school grades to date.
- ✓ An official copy of your university transcript(s) to date.

### WHEN SHOULD I APPLY?

It is recommended that you apply as early as possible, but applications should be received by **April 15<sup>th</sup>**. Applications received after this date will be assessed as resources and space allow.

International Students: The application deadline for international students is **March 1<sup>st</sup>**.

### PHYSICAL REQUIREMENTS

Applicants to selected Marine Institute programs are required to provide proof of physical fitness prior to registration.

The two medicals involved are known as the Transport Canada Marine Medical Certificate (TC), and the Canadian Association of Petroleum Producers Offshore Medical (CAPP).

Students must present proof of physical fitness to the Registrar's Office with the appropriate medical form signed by the authorized physician. Please note that medicals do expire and may need to be repeated prior to completion of a program.

# ADMISSION REQUIREMENTS

## DIPLOMAS OF TECHNOLOGY AND TECHNICIAN DIPLOMAS - NEWFOUNDLAND APPLICANTS

Applicants shall have completed Graduation requirements for high school as set down by the Department of Education and obtained credits in each of the following, with a minimum combined average of 60% in the level three Mathematics, English and Science.

**Mathematics:** Four (4) math credits, two (2) which must be either Math 2201 or Math 2200; and two (2) credits from either Math 3201\* or Math 3200  
\*a minimum of 60% must be achieved in this course

**Language:** Two (2) credits from English 3201

**Science:** Four (4) credits, two (2) of which must be from either Biology 3201, or Chemistry 3202, or Physics 3204, or Earth Systems 3209

## DIPLOMAS OF TECHNOLOGY AND TECHNICIAN DIPLOMAS - APPLICANTS FROM OUTSIDE NEWFOUNDLAND

Canadian citizens who reside outside Newfoundland and Labrador require a Grade XII graduation diploma in a University Preparatory Program (the Secondary V Certificate for Quebec applicants) with a passing mark in the required courses equivalent to those identified for Newfoundland applicants and an overall average of no less than 60% in these courses.

## TECHNICAL CERTIFICATE PROGRAMS

Applicants require completion of the grade required for the particular program for which they are applying.

## MATURE STUDENTS

Mature students are 21 years of age or older within one (1) month of the start of the program. The admission requirements above describe the minimum qualifications individuals should have in order to succeed in each respective program area. Individuals may obtain the equivalent or other suitable qualifications from alternate sources to prepare them for technology programs.

Applicants must demonstrate they have a technical or practical expertise, or a combination of both, in their intended field of study. Mature applicants should submit an Application for Admission, as well as the following documentation:

- A resume outlining all associated experience
- A letter of recommendation from an employer or other individual who can attest to an applicant's qualifications
- Official academic transcripts of high school and post-secondary studies
- Proof of age

## TRANSFERS FROM OTHER CANADIAN UNIVERSITIES/COLLEGES

Students from other universities/colleges will be considered for admission upon producing satisfactory documentation. Students forced to withdraw from another university/college will not be eligible for admission to the Marine Institute until the associated withdrawal penalty has been served. Students transferring from other universities/colleges, and students with prior academic or work experience may apply for Credit Transfer or Challenge Examinations. Please refer to the Marine Institute Calendar for the policies, regulations and procedures governing transfers of credit and challenge examinations.

## APPLICANTS FROM OTHER COUNTRIES

Please refer to the Marine Institute Calendar for regulations governing English Proficiency Requirements. Information on entering Canada to study as a foreign student should be obtained from the applicant's nearest Canadian Embassy or Consular Office.

**DIPLOMA OF TECHNOLOGY/BACHELOR OF TECHNOLOGY, DIPLOMA OF TECHNOLOGY, TECHNICIAN DIPLOMA AND TECHNICAL CERTIFICATE PROGRAMS**

Applicants who have completed high school must have an official high school transcript, issued by the Department of Education, sent directly to the Office of the Registrar at the Marine Institute. In addition, applicants who have attended other colleges or universities are required to have all official transcripts submitted by the appropriate institution directly to the Registrar’s Office of the Marine Institute. Applicants who are currently attending their final year of high school should apply immediately. High school information will be obtained directly from the Department of Education. Applicants from outside Newfoundland who are currently attending their final year of high school should apply immediately and submit an official interim transcript which includes all courses for which they are currently registered.
